The Arc of Chester County has been named the J. Dewees Mosteller Community Service Award winner by the Greater West Chester Chamber of Commerce, in recognition of its ongoing, outstanding commitment to the community. The award, given annually since 1961, was presented at a banquet held February 5 at the Mendenhall Inn. Executive Director Jeanne Meikrantz, board members and members of The Arc's senior staff attended.

In addition, Michelle Talis, who receives Arc services through Agency with Choice, Comprehensive Employment Services and Family Support Services, was invited to attend the

dinner, with her parents. Michelle's presence was a living example of the quality of The Arc services and the way they support different facets of an individual's life. Michelle is currently employed at Cosi's restaurant in Exton where she delivers food and busses tables. Cosi was selected as The Arc's Employer of the Year in 2012.

Dear Friends,

As I think back over the years I have been associated with The Arc, I am struck by the role The Arc has played in educating the community. Raising awareness of disabilities has been an integral part of our mission and we have accomplished that in so many ways. We have changed

the public dialogue around the words describing disabilities by promoting "People First" language and discouraging the use of the "R" word. Our Count Me In© puppet show teaches elementary-aged students that children with disabilities are not so different after all. The First Step Early Intervention program partners with numerous local organizations to give its students opportunities to swim at the YMCA, go grocery shopping at the Acme and practice getting a haircut. The Advocacy program has recently begun to offer free clinics to parents to give them the tools they need to advocate for their children in the local school districts. I am proud that The Arc continues to lead the way in encouraging a respectful and inclusive attitude toward people with disabilities through both its example and its innovative educational programs.

# **Generous Community Supporters**of The Arc

he Arc has recently been the recipient of several generous donations from a diverse group of organizations.

- Roger Fryberger, husband of Robin, The Arc's Director of Administration, suggested The Arc to his employer, Tri-State Tech Sales of Malvern, as the recipient of their annual holiday gift to a local non-profit. Nine of their employees, including Roger, contributed funds which were then matched by the company for a grand total of \$3,430.

The Arc of Chester County has numerous partners in the community who support our mission and help us provide individuals with disabilities and their families with the services and programs they need. Our goal is to integrate and include people with disabilities into the community but we can't do this work alone. Here are some groups who have reached out to us because they are drawn to our mission and want to offer their time and energy:

### Hershey's Mill

Trick or treating is a typical childhood activity with which children with disabilities may struggle. Costumes, noise and knocking on a an unfamiliar door can cause stress and anxiety in children who experience sensory issues. Residents of the Quaker Ridge neighborhood in Hershey's Mill opened up their doors several days before Halloween to give our First Step students a chance to "practice" trick or treating. Teachers and therapists worked with the children to break down the process into manageable steps, which allowed the children to experience the excitement of learning a new skill outside of their classroom. The residents enjoyed it as much as the students, resulting in the addition of several new volunteers to our First Step program. Harriet Bernstein and June Duncan will be bringing their love of music into the classrooms by playing piano and singing songs with the children.

#### **Christ Church in the Valley**

This Royersford church has a loyal volunteer group who has helped us in the past with a variety of necessary tasks. This year, they undertook the big job of hand-addressing the hundreds of envelopes for our Milestones campaign. Our development staff is extra-grateful for this help!

### Shipley students

Middle School students from Shipley School in Bryn Mawr have been working with our First Step students in the class-room once a month. They have taken on the additional project of learning and practicing our Count Me In© Puppet Show, that is presented to local schools and community groups to educate children about people with disabilities. They were able to present the puppet show to fellow students at Shipley's Disability Awareness Day.

### **Upper Main Line Rotary**

This enthusiastic group of local business-people is new to The Arc, but they've already made a huge contribution by helping out at our Breakfast with Santa event. They kept the kitchen running smoothly, flipped pancakes and assisted wherever needed. # The Arc Helps Develop Future Social Workers

as a year-long field placement for students in local university undergraduate and graduate programs who are studying to be social workers. Our current interns spend 16 hours per week here and each has a caseload of about four families. They are working as liaisons between the First Step staff and families whose children are served in the program. Their interactions with the families include such things helping them through the process of obtaining Medical Assistance, answering general questions from families about their child's day and visiting families in their homes to ensure continuity of care between school and home.

Several of our current interns spoke with us about their reactions to the placement. Haley, who is interested in becoming an equine-assisted psychotherapist working with children and young adults, shared that one of the most important lessons she has learned is how to be a professional member of a team. "Also, I've been exposed to many different types of families, of diverse cultures, who represent worlds beyond what I've ever experienced," she explained, "and I'm learning how to relate to people whose customs, practices and languages are unfamiliar to me." Christine, whose goal is to work with Hispanic families, offered the perspective of coming from a different state whose laws and regulations differ from Pennsylvania and Chester County. Both young women agreed that the most challenging issue they've encountered is learning how difficult it is for some families to access services, or even to be aware of what's available.
